NOTIFICATION

S.O. In exercise of the powers conferred by sub-section (2) of the section 11 of the Indian Medical Council Act, 1956(102 of 1956), the Central Government, after consulting the Medical Council of India, hereby makes the following further amendments in the First Schedule to the said Act:

In the said First Schedule after "Indira Gandhi Institute of Medical Sciences, Patna" and under the heading 'Recognized Medical Qualification' [Hereinafter referred to as column (2)], after the last entry and entry relating thereto under the heading 'Abbreviation for Registration' [Hereinafter referred to as column (3)], the following shall be inserted, namely:-

Bachelor of Medicine and Bachelor of Surgery	M.B.B.S. This shall be a recognized medical qualification when granted by Indira Gandhi Institute of Medical Sciences, Patna in respect of students being trained at Indira Gandhi Institute of Medical Sciences, Patna with annual intake of 100 MBBS students on or after January, 2016.

(b) In the said First Schedule after "West Bengal University of Health Sciences, Kolkata" and under the heading 'Recognized Medical Qualification' [Hereinafter referred to as column (2)], after the last entry and entry relating thereto under the heading 'Abbreviation for Registration' [Hereinafter referred to as column (3)], the following shall be inserted, namely:-

Bachelor of Medicine and Bachelor of Surgery	M.B.B.S. This shall be a recognized medical qualification when granted by West Bengal University of Health Sciences, Kolkata in respect of students being trained at College of Medicine & Sagore Dutta Hospital, Kolkata with annual intake of 100 MBBS students on or after February, 2016.

(c) In the said First Schedule after "Dr. N.T.R. University of Health Sciences, Vijayawada" and under the heading 'Recognized Medical Qualification' [Hereinafter referred to as column (2)], after the last entry and entry relating thereto under the heading 'Abbreviation for Registration' [Hereinafter referred to as column (3)], the following shall be inserted, namely:-

Bachelor of Medicine and Bachelor of Surgery	M.B.B.S. This shall be a recognized medical qualification when granted by Dr. N.T.R. University of Health Sciences, Vijayawada in respect of students being trained at Dr. V.R.K. Women's Medical College, Aziznagar with annual intake of 100 MBBS students on or after February, 2015.

✓(d) In the said First Schedule after "Dr. R.M.L. Avadh University, Faizabad" and under the heading 'Recognized Medical Qualification' [Hereinafter referred to as column (2)], after the last entry and entry relating thereto under the heading 'Abbreviation for Registration' [Hereinafter referred to as column (3)], the following shall be inserted, namely:-



Bachelor of Medicine and Bachelor of Surgery	M.B.B.S. This shall be a recognized medical qualification when granted by Dr. R.M.L. Avadh University, Faizabad in respect of students being trained at Mahamaya Rajkiya Allopathic Medical College, Ambedkarnagar with annual intake of 100 MBBS students on or after February, 2016.

(d) In the said First Schedule after "The Tamilnadu Dr. MGR Medical University, Chennai" and under the heading 'Recognized Medical Qualification' [Hereinafter referred to as column (2)], after the last entry and entry relating thereto under the heading 'Abbreviation for Registration' [Hereinafter referred to as column (3)], the following shall be inserted, namely:-

Bachelor of Medicine and Bachelor of Surgery	M.B.B.S. This shall be a recognized medical qualification when granted by The Tamilnadu Dr. MGR Medical University, Chennai in respect of students being trained at Sri Muthukumaran Medical College, Hospital & Research Institute with annual intake of 150 MBBS students on or after February, 2015.

- Note: 1. The recognition so granted to an undergraduate courses for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.
2. The procedure for 'Renewal' of recognition shall be same as applicable for the award for recognition.
3. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned undergraduate Course.
